2. ALCOHOL is not permitted at the event.
3. Vendor booth cancellations must be made by April 27, 2020, in order to receive a refund. No refunds will be granted after this date.
4. Vendors must list all items to be sold or given away on the Vendor Booth Application. Sales of pornographic materials, weapons, drugs or fireworks are prohibited. The Vendor Coordinator has final approval on all items for sale or distribution.
5. The event organizer (MDMEF) will assign spaces for all vendors.
6. MDMEF is not responsible for a vendor's financial success at the event.
7. Setup time is 10:00 – 12:00 noon on May 9, 2020. There is parking for 1 or 2 vendor vehicles around the Plaza. You'll need to place a placard on your dashboard, which you can pick up at our MDMEF booth.

A waiver form is required for all vendor booth representatives. Only those with a completed waiver on file will be permitted on site.
